INTERVIEW WITH MR GREG FLYNN OF FLYNNS WINE ESTATE





Tell us about Flynns Wines

Flynns Wines was established from the ground up by Greg & Natala Flynn. We searched through 43 properties in the Heathcote area before deciding on a 75 acre block of land that seemed to fit most of our criteria. Then set about constructing buildings and putting in post, trellising and vines which we did with our own hands.

Our philosophy was to produce boutique wines that were premium and individual, that reflect our vineyard, Heathcote regionality and our own style. We like to control the process from growing the fruit, making the wine, through to selling the finished bottle. To us it's not a job, we live and breath it and love to involve people who are interested in wine and hopefully supply them with the best experience we can.

Why did you sponsor the HKABA Food and Wine Dinner event?

When sponsoring the event was offered to us by one of our James Flynn Wine Club members, we thought that it was a terrific opportunity to tell the wider business community about what we do. We thought that this would be a great chance to meet like minded people in business and who love food, wine and life experience. As we think our main competitive advantage is giving guests a great wine experience.

Federal Budget 2012/2013

We were told that this would be a tough budget, and the Government's mantra has held true. The Treasurer has had the unenviable task of choosing between multiple deserving reforms, while delivering a \$1.5 billion budget surplus in the face of plummeting tax receipts.

In terms of the broader economic narrative, the return to budget surplus is intended to demonstrate the Australian economy's full recovery from the global financial crisis. But the economic data shows the limitations of this recovery. Many industries continue to experience slow growth, and certain regions, such as Victoria, are already growing at below trend rates. The Government's response to this is to structure a budget that is designed to spread the benefits of the resources boom.
